- 7. All tenders must be accompanied by a Bid securing Declaration in an acceptable format as per section IX of the Tender Document.
- 8. All bids in **One original plus two copies** properly filled in, and enclosed in plain envelopes must be Submitted to the address indicated in the **Bid data sheet** at or before **10.00am**, **on 20**<sup>th</sup> **May, 2015**, **Wednesday**. Bids will be opened promptly thereafter in public and in the presence of Bidders or Bidders' representatives who choose to attend the opening Ceremony at the **National Electoral Commission Conference Room 703**, **Posta House**, **7**<sup>th</sup> **floor**, **Junction to Ohio/Ghana Street**.
- 9. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
