Tume ya Taifa ya Uchaguzi imepewa jukumu la kusimamia na kuratibu uendeshaji wa uchaguzi wa Rais na Wabunge kwa Jamhuri ya Muungano na Madiwani kwa Tanzania Bara. Jukumu hili limeainishwa chini ya Ibara ya 74 (6) (b) ya Katiba ya Jamhuri ya Muungano wa Tanzania ya mwaka 1977. Sehemu ya V ya Kanuni za Uchaguzi wa Rais na Wabunge na Sehemu IV ya Kanuni za uchaguzi wa Serikali za Mitaa (Uchaguzi wa Madiwani) za mwaka 2020 zimeipa Tume mamlaka na maelekezo ya namna ya kusimamia na kuendesha masuala ya utazamaji wa uchaguzi nchini.

Katika kufanikisha jukumu hilo Tume ilitoa Tangazo la mwaliko kwa watazamaji wa ndani kuwasilisha maombi ya kutazama Uchaguzi Mkuu wa mwaka 2020. Tangazo lilitolewa tarehe 27 Novemba, 2019 na liliainisha kuwa mwisho wa kupokea maombi ni tarehe 31 Januari, 2020.
